Addendum to Employee Handbook

WHEREAS, the Town Board is to clarify provisions of the handbook with regard to new hire of highway employees starting wage;

WHEREAS, the Town Board is to clarify provisions of the handbook with regard to highway employees health benefits;

NOW, THEREFORE IT BE RESOLVED, by the Town Board of the Town of Boonville at regular session duly convened as follows: Section II of the Employee Handbook entitled "Employment Matters" 29 a., is hereby to add a starting wage to read as follows:

FIRST: All new hires in the Town Highway Department will be paid a starting wage of \$21.50 per hour for a probation period of two years. At the end of the second year the employee will receive a salary commensurate with rest of the Town Highway Employees, and;

SECOND: All new hires in the Town Highway Department must have a CDL
